**HOW TO USE:** Shake the TRICO GARDEN container prior to opening. Dilute TRICO GARDEN at a ratio of 1 part product in 3 parts water (1:3) to 1 part product in 5 parts water (1:5) and apply using a sprayer fitted with a medium nozzle. 150 - 200mls TRICO GARDEN are applied in a final volume of 0.3 - 1.0/1 00m2.

APPLICATION: Rate: TRICO GARDEN should be applied as a dilute spray to trees, shrubs and ornamental plants. For specimen trees a rate of 12 - 20mls/tree should be used. Timing: At the first signs of damage. In the Autumn: a single application may be sufficient to repel deer but if the risk of damage persists a second application can be made 28 days after the first application. In the Spring: a single application may be sufficient to repel deer but if the risk of damage persists a maximum of three repeat applications can be made at 28 days intervals.

NOTE: A maximum of four applications are permitted per annum.

During hot weather carry out the application in the morning or evening as in high temperatures and intense sunlight there is a risk of damage to soft tissue such as leaves and young shoots. To be effective the application must dry on the target.

**PLANT SAFETY:** TRICO GARDEN has been found to be safe to use on all species of hardwoods and conifers during the autumn/winter period of use. In addition no phytotoxic effects following a spring/summer application have been recorded on the following plant species:

Geranium sp. Roses Daisies Viola sp Forsythia sp. Laburnum Weigela Begonias Salvia sp.

It is strongly recommended that a single plant is treated first to ascertain whether phytotoxic effects are evident before treating large areas. In addition the recommendations in the HOW TO USE section should be followed.

A deer repellent containing 64.6 g/L sheep fat as an oil in water emulsion for use in the garden to reduce damage caused by browsing deer.

WHERE TO USE: TRICO GARDEN is a repellent by smell. The dilute spray is applied to vulnerable parts of ornamental plants, shrubs and trees to reduce damage caused by deer browsing. The smell of sheep fat keeps deer away from treated plant material and hence reduces damage by browsing.
